

### **Privacy Policy**

Welcome to the website (the "Site") of Keyda Ventures REAL ESTATE. ("Keyda Ventures," "we," "us" and/or "our"). This Site is operated by Keyda Ventures and has been created to provide information to our visitors ("you," "your") about our company and our online content, tools and services related to the marketplace lending market, whether such content, tools and services are accessed on the Site or through third-party websites, mobile sites and/or applications (together with the Site, the "Services"). This Privacy Policy describes how Keyda Ventures collects, uses and discloses information from visitors to the Services, including personally identifiable data ("Personal Data").

Please be sure to read this entire Privacy Policy before using or submitting information through the Services. By using or submitting information through the Services, you are indicating that you agree to be bound by the terms of this Privacy Policy. This Privacy Policy is incorporated into Keyda Ventures' Terms of Service.

#### Information We Collect:

When you interact with us through the Services, we may collect Personal Data and other information from you, as further described below:

## Personal Data That You Provide Through the Services:

We collect Personal Data from you when you voluntarily provide such information, such as when you access, complete and/or use one of our online forms, tools or content items, contact us with inquiries, respond to one of our surveys, register for access to the Services or use certain Services. If you complete one of our online forms, you may be asked to provide Personal Data such as your email address, first and last name, street address (including zip code), telephone number, date of birth and social security number. For clarity, Keyda Ventures collects Personal Data from you to, in part, provide you with personalized content and information related to your growth prospects.

By voluntarily providing us with Personal Data, you are consenting to our use of it in accordance with this Privacy Policy. You represent that the Personal Data you provide is true, accurate, current and complete, and that you have the authorization to provide it to us. If you provide Personal Data to the Services, you acknowledge and agree that such Personal Data may be transferred from your current location to the offices and servers of Keyda Ventures and the authorized third parties referred to herein located in Kenya.



#### Other Information:

IP Addresses; Device ID Information: The requests you make to Keyda Ventures may contain your IP address (the Internet address of your computer). We may use visitors' IP addresses for various purposes, including to display customized content and analyze and report upon usage of the Services; to diagnose and prevent service or technology problems affecting the Services; and to monitor and prevent fraud and abuse. If you access the Services on a mobile device, we may also collect your device identification number and request access to settings and location information for similar purposes and to personalize your experience with the Services.

Non-Identifiable Data: When you interact with Keyda Ventures through the Services, we receive and store certain personally non-identifiable information. Such information, which is collected passively using various technologies, cannot presently be used to specifically identify you. We may store such information ourselves or such information may be included in databases owned and maintained by Keyda Ventures affiliates, agents or service providers. The Services may use such information and pool it with other information to track, for example, the total number of visitors to the Services, the number of visitors to each page of our Site, and the domain names of our visitors' Internet service providers. It is important to note that no Personal Data is available or used in this process.

In operating the Services, we may use cookies, web beacons and similar technologies. A cookie is a piece of information that the computer that hosts our Services gives to your browser when you access the Services. Cookies help provide additional functionality to the Services, customize users' experiences with the Services and help us analyze Services usage more accurately for research, advertising and marketing purposes. On most web browsers, you will find a "help" section on the toolbar. Please refer to this section for information on how to receive notification when you are receiving a new cookie and how to turn cookies off. We recommend that you leave cookies turned on because they allow you to take advantage of some of the Services' features.

In addition to cookies, we may use web beacons (also known as "clear GIFs") to measure traffic to or from or use of our online forms, tools or content items and related browsing behavior and to improve your experience when using the Services. We may also use customized links or other similar technologies to track hyperlinks that you click and associate that information with your Personal Data in order to provide you with more focused communications.



This Privacy Policy covers the use of cookies, web beacons and similar technologies by Keyda Ventures only. Uses of these technologies by third-party advertisers or websites linked from the Services, including third parties with which we partner, are governed by each such advertiser or website's privacy policy.

Aggregated Personal Data: In an ongoing effort to better understand and serve the users of the Services, Keyda Ventures often conducts research on our customer demographics, interests and behavior based on the Personal Data and other information provided to us. This research may be compiled and analyzed on an aggregate basis, and Keyda Ventures may share this aggregate data with our affiliates, agents, consultants and service providers. This aggregate information does not identify you personally. Keyda Ventures may also disclose aggregated user statistics in order to describe our services to current and prospective clients and consultants, and to other third parties for other lawful purposes.

### Our Use of Your Personal Data and Other Information:

Keyda Ventures uses the Personal Data you provide in a manner that is consistent with this Privacy Policy. If you provide Personal Data for a certain reason, we may use the Personal Data in connection with the reason for which it was provided. For instance, if you contact us by email to ask a question or report an issue with the Services, we will use the Personal Data you provide to answer your question or resolve your problem. Also, if you provide Personal Data in order to learn about our services, we will use your Personal Data to provide you with information on such services, to provide other personalized services, and/or to monitor your use of the Services. Keyda Ventures and our consultants and affiliates (the "Keyda Ventures Related Companies") may also use your Personal Data and other personally non-identifiable information collected through the Services to help us improve the content and functionality of the Services, to better understand our users and to improve the Services.

**Marketing:** Keyda Ventures and Keyda Ventures' consultants and service providers whom we share your information for product pricing may use your Personal Data to communicate with you by email, postal mail, or by text message to provide you with:

Information regarding your request for services status.

Opportunities and promotions available through the services of our consultants and service providers that we think may be of interest to you.

Information or content – such as articles or white papers – that we believe would be of interest to you though e-mail, text messages, or postal mail.



We will send such emails only with your consent, which is gathered when you either register for Keyda Ventures' services or sign up for future communications. Each marketing-related communication we send you will contain instructions permitting you to "opt-out" of receiving future marketing communications. If Keyda Ventures intends on using any Personal Data in any manner that is not consistent with this Privacy Policy, you will be informed of such anticipated use prior to or at the time at which the Personal Data is collected.

### Our Disclosure of Your Personal Data and Other Information:

Keyda Ventures is not in the business of selling your information. We consider this information to be a vital part of our relationship with you. There are, however, certain circumstances in which we may share your Personal Data with certain third parties without further notice to you, as set forth below:

Certain Business Partners: When we partner with other businesses to provide content or services to you or to such business partners, we may share relevant Personal Data in connection with such content or services. For example, we will share your contact and other information with a consultant and/or service provider if the information you provide in one of our online forms or tools matches certain criteria for services offered by such lender consultant.

**Business Transfers:** As we develop our business, we might sell or buy businesses or assets. In the event of a corporate sale, merger, reorganization, dissolution or similar event, Personal Data may be part of the transferred assets.

**Related Companies:** We may also share your Personal Data with the Keyda Ventures Related Companies for purposes consistent with this Privacy Policy.

Agents, Consultants and Related Third Parties: Keyda Ventures, like many businesses, sometimes hires other companies to perform certain business-related functions. Examples of such functions include mailing information, maintaining databases and providing marketing assistance. When we employ another entity to perform a function of this nature, we only provide them with the information that they need to perform their specific function.

**Legal Requirements:** Keyda Ventures may disclose your Personal Data if required to do so by law or in the good faith belief that such action is necessary to (i) comply with a legal obligation, (ii) protect and defend the rights or property of Keyda Ventures, (iii) act in urgent circumstances to protect the personal safety of users of the Services or the public, or (iv) protect against legal liability.



#### Your Choices:

You can visit the Services without providing any Personal Data. If you choose not to provide any Personal Data, you may not be able to use certain features of the Services.

### **Exclusions:**

This Privacy Policy does not apply to any Personal Data collected by Keyda Ventures other than Personal Data collected through the Services. This Privacy Policy shall not apply to any unsolicited information you provide to Keyda Ventures through the Services or through any other means. This includes, but is not limited to, information posted to any public areas of the Services, such as forums, any ideas for new products or modifications to existing products, and other unsolicited submissions (collectively, "Unsolicited Information"). All Unsolicited Information shall be deemed to be non-confidential and Keyda Ventures shall be free to reproduce, use, disclose, and distribute such Unsolicited Information to others without limitation or attribution.

## Children:

Keyda Ventures does not knowingly collect Personal Data from children under the age of 18. If you are under the age of 18, please do not submit any Personal Data through the Services. We encourage parents and legal guardians to monitor their children's Internet usage and to help enforce our Privacy Policy by instructing their children never to provide Personal Data on the Services without their permission. If you have reason to believe that a child under the age of 18 has provided Personal Data to Keyda Ventures through the Services, please contact us, and we will endeavor to delete that information from our databases.

# Links to Other Websites:

This Privacy Policy applies only to the Services. The Services may contain links to other websites not operated or controlled by Keyda Ventures (the "Third Party Sites"). The policies and procedures we described here do not apply to the Third Party Sites. The links from the Services do not imply that Keyda Ventures endorses or has reviewed the Third Party Sites. ### Security:

Keyda Ventures takes reasonable steps to protect the Personal Data provided via the Services from loss, misuse, and unauthorized access, disclosure, alteration, or destruction. Therefore, you should take special care in deciding what information you send to us via email. Please keep this in mind when disclosing any Personal Data to Keyda Ventures via the Internet.
